Our VPK program specializes in Kindergarten Readiness. We focus on inclusive practices and excel at working with children and families with special needs.

No more than 20 children per class.



One teacher for every 11 children



The teacher has her 5 hour VPK literacy accreditation



The lead teacher must have a  
National Child Development Associate Certificate  
Florida Child Development Associate Certificate; or  
college degree



The program must offer 540 hours of instruction during the school year, & 3



The school must pass licensing inspections



The provider must be either a licensed teacher (or an equivalent), a social worker, or a teacher of

Hold a current Gold Seal Quality Care designation; or
